- c) where the maximum allocated days are exceeded,

then additional time will be charged at pro rata \$800.00 per day.

Where Witness Assessors are sourced from other Accreditation Bodies, and other sources, the fee rate per day may vary. Should this occur the cost shall be invoiced at cost plus a 15% administration fee.
