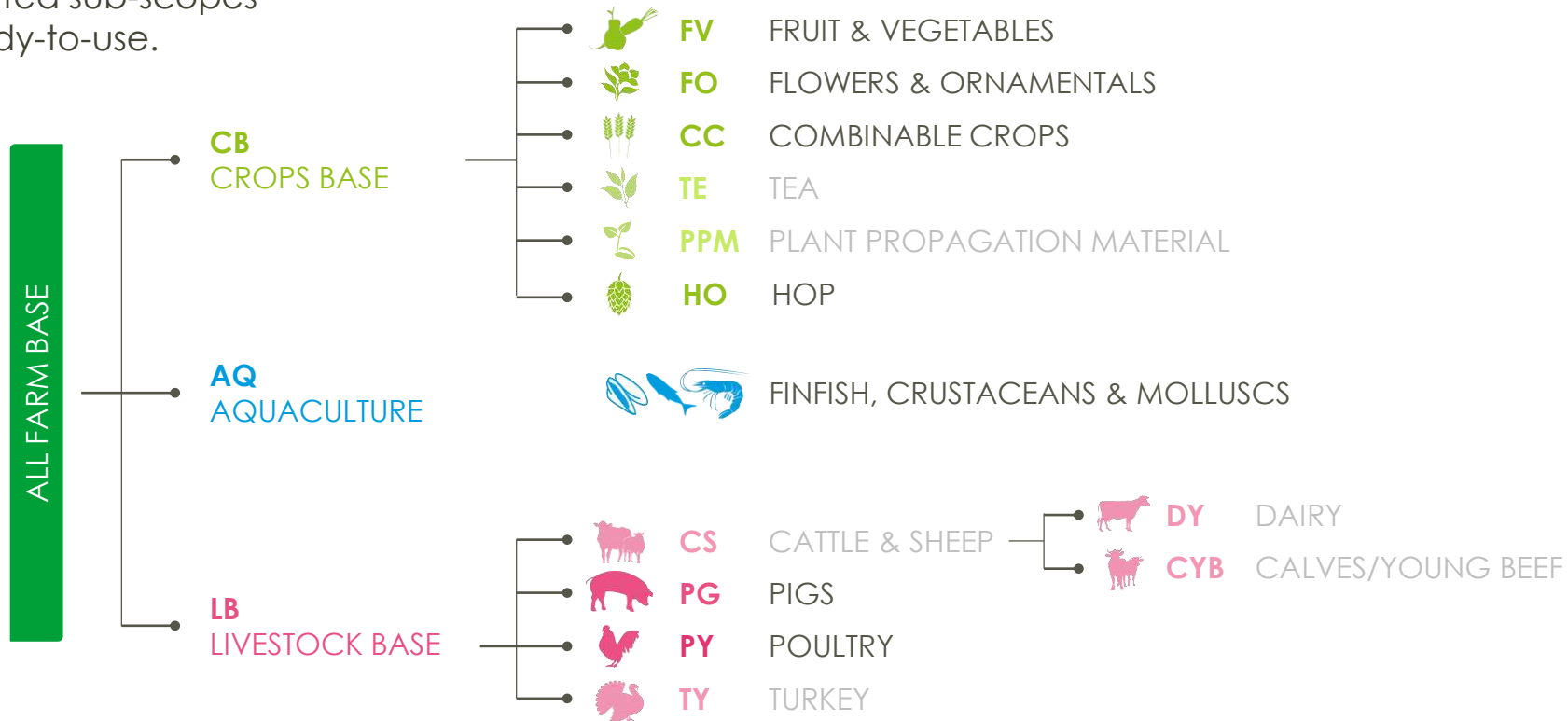

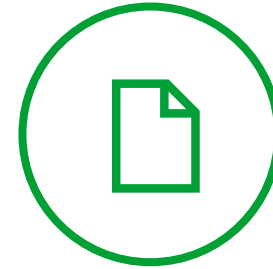

## **Food Safety Modernization Act Produce Safety Rule (FSMA PSR)**

## **OTHER WORKSHOPS: PSA GROWER TRAINING COURSE**

The PSA Grower Training Course is one way to satisfy the FSMA Produce Safety Rule requirement that states: *“At least one supervisor or responsible party for your farm must have successfully completed food safety training at least equivalent to that received under standardized curriculum recognized as adequate by the Food and Drug Administration.”*

- The client shall provide a contact person for GLOBALG.A.P. before and during the workshop. The contact person needs to be fluent in English.
- The client shall organize at its own expense adequate meeting facilities for conducting the workshop. If the workshop includes on-farm-training sessions, the client shall search for an adequate farm and ensure that the workshop participants are able to visit that farm and participate in the training there.
- The client shall be responsible for the safety of the participants at the meeting facilities and during the on-farm-training sessions and ensure that any special safety measures that are necessary will be taken. If necessary, the client shall organize protective gear for the participants and ensure that the participants are familiar with the adequate use of the protective gear, and that they will receive all necessary safety instructions.
- The client is responsible for inviting the participants, who may consist of the client's staff or business partners.
- For the purpose of an optimal workshop experience, the maximum number of participants shall not exceed 15.



- GLOBALG.A.P. shall send at its own expense a qualified trainer who will conduct the workshop with the participants and who will also conduct any exams if such exams are part of the workshop.
- GLOBALG.A.P. provides all necessary workshop materials and documents, including any hand-outs for the participants, attendance certificates, and exam papers in written or electronic form. The client may print out all documents provided in electronic form. GLOBALG.A.P. also provides brochures and name tags.



### **Classroom**

- The workshop fee for a group of up to 15 participants is a fixed fee of € 2,500 per day (start and end date are deemed to be full days).

### **Webinar**

- The workshop fee is a fixed fee of € 2,000 per day independent of the number of participants.
